PERSONAL INFORMATION COLLECTION

How Your Medical Information Will Be Used And Disclosed:

Prescription Hope, Inc. will use your medical information as part of rendering our prescription assistance services and functioning as a health enrollment counselor. For example, your medical information may be used by the health care professional assisting you, by the business office, to process your payment for the services rendered and by administrative personnel reviewing the quality and appropriateness of the service you received.

Where the Prescription Hope, Inc. discloses your personal information to its agents or sub-contractors for these purposes, the agent or sub-contractors for these purposes, the agent or sub-contractor in question will be obligated to use the personal information in accordance with the terms of this privacy statement. In addition to the disclosures reasonably necessary for the purposes identified elsewhere above, Prescription Hope, Inc. may disclose your personal information to the extent that it is required to do so by law, in connection with any legal proceedings or prospective legal proceedings, and in order to establish, exercise or defend its legal rights.
